1.0 Background

For the last 26 years, the Alberta Construction Safety Association (ACSA) has held a conference for its community of National Construction Safety Officers (NCSO) and Health & Safety Administrators (HSAs). In 2018, we renamed the conference as The ACSA Conference, and expanded its appeal to include not just NCSOs & HSAs, but also owner-operators, senior managers, and company leaders with an interest in safety. Our 2018 conference in Calgary drew over 500 attendees.

Speakers are invited to present on health & safety related topics and workshops related to our theme, **Facing Disruption: Building Sustainably.** We intend for participants to gain new knowledge and ideas that are applicable in their workplaces.

2.0 Program

This two day conference will consist of a series of breakouts / workshops at different times across the two days. Each breakout is scheduled to be 90 minutes long.

- Changes to COR / SECOR
- Changes at WCB Alberta
- Global trade tensions / USMCA
- Rise of bigotry / #MeToo / populism / tolerance and similar
- Truth & reconciliation
- Legalised cannabis
- Energy issues & conservation & sustainability
- Global climate changes & sustainable building practices

3.1 Submission Requirements

Your proposal should include the following:

- A summary outlining the applicant's relevant background and experience
- A description of the workshop or presentation proposed, and for which session & day
- A brief description of "What separates you from your competitors?"
- A sample of previous work (workshop handouts, YouTube video, books etc.)
- AV requirements
- Maximum number of participants in the workshop
- Type of presentation workshop or lecture style
- Preferred session type (plenary or workshop) and the length of your presentation (45 mins, 90 mins, or 60 mins)
- Cost for services

We would like to see three references accompanying the submission with a statement of permission for ACSA to contact each of them.

5.1 Total Cost (Weight 50%)

Total cost for the workshop or presentation

5.2 Relevant Workshop/Presentation (Weight 45%)

Previous experience, including references

5.3 Presentation of Proposal (Weight 5%)

Clarity of the written proposal and the thoroughness of proposal
